I HAVE READ THE RELEASE, I UNDERSTAND IT FULLY, I UNDERSTAND THAT IT IS LEGALLY BINDING, AND I UNDERSTAND THAT, AMONG OTHER THINGS, I AM AGREEING TO WAIVE ANY CLAIM FOR INJURIES, DAMAGES, OR LOSSES MINOR PARTICIPANT MAY SUFFER AS A RESULT OF THE ACTIVITY.
